All MRSA positive patients, except babies < 4 months old, must be commenced on ONE of the following MRSA decolonisation prescriptions, after agreement by the Infection Control Team.

Guidance for application of specific components of MRSA decolonisation protocol:

Mupirocin ointment must NOT be used on or near plastic material e.g. I.V. lines, NG tubes, O_2 nasal cannulae, PEG tubes, drains or deep extensive wounds ≥ 10 cm or surface area ≥ 100 cm².

Poly ethylene-glycol, the ointment base in Mupirocin ointment, can accumulate in patients with renal impairment. It is not to be used on a large surface area, when an occlusive dressing is used or on broken/damaged skin e.g. ulcers. It also damages integrity of plastic material. (Mupirocin Nasal Ointment does not contain poly-ethylene-glycol can be used on sites with indwelling devices).

Hibiscrub - For bedbath; add 25mls to half a bowl of water. Apply neat to skin and rinse thoroughly if showering. Hair conditioner and body moisturiser must not be used until 4 hours after application of Hibiscrub.

Octenisan - For washing; apply undiluted to a damp facecloth, rub onto the areas of the body to be cleansed, leave for 3 minutes contact time and wash off. For showering or hair washing, use in the same way as normal preparations.

Prontosan: For application to wounds: Ensure wound is clean. Copiously coat wound/wound bed with gel. Wound gel can stay on the wound until the next change of dressing. Vary quantity of gel depending on the frequency of dressing changes:

- larger quantity: e.g. when the dressing is changed only after several days.
- smaller quantity: when dressing is changed on the next or same day.

Mild burning sensation rarely occurs after application, but disappears after a few minutes

Ensure bed linen, clothing and towels are changed daily.

After 5 days dispose of all items dispensed for the protocol (tubes of ointment etc.) to prevent their continued use.

Guidance for re-screening and repeating MRSA decolonisation protocol:

- Patients with MRSA in urine, sputum, deep wounds, around lines and drains:

Complete the protocol. Do not re-screen/repeat protocol

- Patients with MRSA in nose, groin or superficial wounds:
- re-screen all sites 24 hours after protocol completion. Continue with isolation precautions. If post-treatment samples are negative continue isolation precautions and re-screen all sites.
- In total, 3 screens at least 3 days apart are required before a patient can be considered MRSA negative. Consult with the Infection Control Team before relaxing precautions.
- If post treatment samples are positive give a second protocol, but no more than 2 in a 6 month period.
